

MINUTES

64th Annual General Meeting Indian Geotechnical Society 1900 hrs, Thursday, the 15th December 2022 Hotel Le Meridien, Kochi

ITEM 0 WELCOME BY THE PRESIDENT

Prof. N.K. Samadhiya, IGS President, welcomed the members to 64th Annual General Meeting at the scheduled time. However, the meeting was adjourned for want of quorum and was reconvened after a break of two minutes.

Prof. N.K. Samadhiya, President, IGS thanked IGS-Kochi Chapter for making all necessary arrangements for the meeting.

The General Body was informed that many IGS members passed away this year. The General Body observed a two-minute silence as a mark of respect.

The President welcomed the Past Presidents of IGS, Members of existing and new Executive Committee and Members of IGS to 64th AGM. Subsequently, the agenda items were taken up for discussion.

ITEM 1 CONFIRMATION OF THE MINUTES

The Minutes of 63rd Annual General Meeting held online on 16th December 2021 on Zoom platform were circulated to the members as **Appendix-A** of the Agenda papers. No comments were received from the members. Prof. G.N. Gandhi proposed to adopt the minutes, which was seconded by Prof. R.K. Bhandari. The General Body approved the minutes.

ITEM 2 AUDITED ACCOUNTS FOR 2021-2022

The audited accounts of the Society for the period 01 April 2021 to 31 March 2022 were circulated to the members as **Appendix-B** of the Agenda papers. The salient features of the audited accounts were presented to the General Body using a Power Point Presentation by the Honorary Secretary, Prof. J.T. Shahu. He briefed the General Body on different heads of

Accounts. Shri R.K. Kulkarni proposed to adopt the accounts, which was seconded by Prof. K.S. Rao. The General Body adopted the Audited Accounts for the year 2021-2022.

ITEM 3 REPORT OF THE HONORARY SECRETARY

The Annual Report of the Honorary Secretary for the period between 16th December 2021 to 31st December 2022 was circulated to the members as **Appendix-C** of the Agenda papers. The same was presented by the Honorary Secretary, Prof. J.T. Shahu, during the meeting using a PowerPoint presentation. He informed about the election results of the New Executive Committee for the term 2023-2024 to the General Body. The members appreciated and adopted the activity report with loud applause.

ITEM 5 TO INSTITUTE AN AWARD IN FORENSIC GEOTECHNICAL ENGINEERING

Prof. J.T. Shahu, Honorary Secretary, IGS informed AGM about the proposal for the institution of an award in Forensic Geotechnical Engineering. The proposal was earlier approved by the Executive Committee. The details of the award were presented to the General Body. The General Body approved the award.

ITEM 6 TO INSTITUTE BEST TEACHER OF GEOTECHNICAL ENGINEERING AWARD

Prof. J.T. Shahu, Honorary Secretary, IGS informed AGM about the proposal for the institution of the 'Best Teacher of Geotechnical Engineering' award. The proposal was earlier approved by the Executive Committee. The details of the award were presented to the General Body. The General Body approved the award.

ITEM 7 HANDING OVER CHARGE TO NEW PRESIDENT

Prof. N.K. Samadhiya, President, IGS handed over the symbolic key of IGS to Dr. Anil Joseph as a token of handing over charge to the President Elect, who will take charge from 1st January 2023.

ITEM 8 SPEECH BY NEW PRESIDENT

The new President, Dr. Anil Joseph thanked AGM for electing him. He appreciated the work carried out by the outgoing Executive Committee during the last two years and the leadership of Prof. N.K. Samadhiya. Dr. Anil Joseph briefed the General Body about his future plans to take the IGS to even greater heights.

At the end of his address, Dr. Anil Joseph thanked one and all, and requested support from all members.

ITEM 9 ANY OTHER ITEM WITH THE PERMISSION OF THE CHAIR

9.1 IGS Foundation

Prof. J.T. Shahu, Honorary Secretary, IGS informed AGM regarding the proposal of creating IGS foundation. The proposal has already been approved by the General Body in its meeting held on 17th December 2020. The purpose of IGS foundation is to create a fund that can be used to undertake technical activities that may create impact.

The general body was informed that a subcommittee of EC was formed to prepare the modalities of IGS foundation. The subcommittee has submitted its report. The subcommittee has now been asked to give the recommendations on the details of the operationalization of IGS foundation. Once the recommendations are received, IGS Foundation will be operationalized. The General Body adopted the proposal.

9.2 Modification in Election Process and Change in the number of coopted members.

Prof. J.T. Shahu, Honorary Secretary, IGS informed AGM about the following proposal to modify the Election Process and change the number of co-opted members.

- 1. The Members shall vote for minimum 50% of the EC member positions (rounded to a higher integer).
- 2. The number of co-opted members shall be increased from exisiting 2 to up to 3. Co-opted members shall have one year duration and shall be picked from unrepresented parts of India by the President. Thus, a maximum of up to 6 Co-opted members can be chosen during the two year duration of EC. A co-opted member shall be replaced if he does not attend two consecutive EC meetings.

The item had already been approved by the Executive Committee and the same was presented to the General Body.

The General Body pointed out that the matter was not circulated earlier. Therefore, the item was deferred to the next AGM.

The Meeting concluded with a Vote of thanks to the Chair.





Efforts are in progress for formation of new chapters at Rewa, Palakkad, Aligarh, Dehradoon, Lucknow and Pondicherry. Life membership of our society have increased considerably with the discount offer in connection with 75th year celebration and the increase in number of Student chapters is appreciable. Happy to note that the student chapters are conducting various technical events in both online and offline mode.

We were able to honour many of the Indian GeolegendS during the IGC 2022 at Kochi and honored Prof. T.G Sitaram, Dr. A.K Dhawan, Prof. Chandan Ghosh, Major General Dr. S N Mukherjee, Prof. A Sridharan, Prof. K.S. Subba Rao, Dr N V Nayak, Dr. R Kuberan and Prof Swami Saran who were not able to make it to IGC 2022. We had the sad demise of Dr R Kuberan on May 8, 2023 and also lost few of our members during this year. I express my deep condolence and pray to the Almighty to give strength to their families to bear the loss, and may the departed souls rest in peace.

As per the invitation of Nepal Geotechnical Society, a four-member team comprising of myself, Dr. A.P. Singh, Prof. Murali Krishna and Prof. Neelima Satyam attended GeoMandu 2023, an International conference on Geohazards and Geo-Infra Disasters organized by Nepal Geotechnical Society held from 16th to 17th March 2023 at Kathmandu. About 350 delegates from 10 countries participated in the conference. A meeting among the representatives of the national member societies in South Asia was held on 16th March 2023 at Radisson Hotel, Kathmandu to discuss the proposal on building a loose network of the South Asian national member societies of ISSMGE. The proposed countries comprise of Nepal, Pakistan, Sri Lanka, Bangladesh and India. Had the opportunity to attend, ISSMGE Asian Regional Technical Committee International Workshop on Geotechnical Engineering for Cultural Heritage Geo-SAKURA 2023 from 15th -16th April 2023 at Nara, Japan. A meeting of the Korean Geotechnical Society, the Japanese Geotechnical Society, and the Indian Geotechnical Society was held during the Workshop and it was decided to start joint biennial workshops with JGS, KGS, and IGS. The first workshop is proposed to be held on May 11, 2024, in Osaka, Japan. The second workshop will take place in Korea in 2026, and the third workshop will be in India in 2028.

I was privileged to lead the Indian Geotechnical Society team to attend the 17th Asian Regional Conference organized by Kazakhstan Geotechnical Society (KGS) at Hotel Hilton, Astana, from 14th to 18th August 2023. The theme of the Conference was "Smart Geotechnics for Smart Societies". About 600 delegates from various geotechnical societies under ISSMGE attended the Conference. From India, 43 papers were submitted, and 36 delegates participated in the Conference. I am happy to inform you all that India has won the bid for hosting the 1st Geotech Asia to be held in 2025 during the Asian Council Meeting held at Astana, Kazakhstan. The idea of starting Geotech Asia was proposed and won with 18-3 voting of the member countries present. After India's presentation for 1st Geotech Asia, all the other three contestants, Thailand, Iran and Pakistan, agreed not to challenge India for 1st Geotech Asia. After the 1st Geotech Asia was awarded to India, India withdrew from the 18th ARC contest, and the voting was carried out.

For the 18th ARC, Thailand got thirteen votes, Iran got eight votes and Pakistan got three votes. 1st Geotech Asia will be held in Mumbai, India in 2025.

Based on the invitation from the Moscow State University of Civil Engineering, participated in the "International Scientific and Practical Symposium: The future of the Construction Industry: Challenges and Development Prospects" organized during 18th to 22nd September 2023 at Moscow, Russia and delivered a Special lecture. As per the invitation received from Sri Lankan Geotechnical Society, attended the Annual conference of Sri Lankan Geotechnical Society as Chief Guest and delivered Keynote address on the theme "Near/offshore Geotechnical Design and Construction" on 23rd October 2023 at Colombo. Visited the geotechnical laboratory of the Centre for Infrastructure Renewal at Texas A&M University, USA, on May 12, 2023, headed by the Director, Prof. Anand Puppala and the possibility of organizing an Indo-US Workshop in 2024 was discussed. Had the opportunity to meet Paul Burton, Secretary TC220 of ISSMGE at Auckland, New Zealand, on June 5, 2023 and requested support for 12th ISFMG 2026 to be held at IIT Indore. Had meeting with Dr Phung Duc Long, President, Vietnamese Society for Soil Mechanics and Geotechnical Engineering at Hanoi on 09.11.2023 and requested support from Vietnamese Society for strong representation in the 1st Geotech Asia to be held at Mumbai in October 2025.

As part of the buildup for the 12th ISFMG Conference to be held at Indore, ISSMGE TC-220, monthly lecture series was inaugurated on August 25, 2023 and Dr Anil Yunatcı, an esteemed expert from GeoDestek Ltd, Turkey, delivered the inaugural session. Dr Lin Wang, Chuo Kaihatsu Corporation, Japan, was the speaker for the second session. The third session was delivered by Dr. Skevi Perdikou and the fourth session was delivered by Dr. Ann Elisabeth Albright Blomberg. Our dynamic website has been launched on September 30, 2023 during the National Executive Committee meeting held at NIT Jalandhar by the hard work and dedication of the team led by Ms. Aarti Bhargava. I am glad to inform that the Indian Geotechnical Journal has received an Impact Factor of 1.4. Thanks to Prof. Ravi Jakka and team for their sincere efforts in publishing our newsletter with rich content. Engineering and also ensuring adequate representation of IGS in the committee for revision of National Building Code.
